

Summary of The Counter Revolution

19. The Counter Revolution is an encyclopaedic reference manual setting out a **Programme of National Reform**.
20. The **Programme of National Reform** set out in The Counter Revolution is a blueprint of detailed proposals to create a new society. It sets out specific constitutional, political, electoral, legal, monetary, educational and social reforms based on the Universal Spiritual Laws, which will stop the Plan and rebuild British civilisation. It fundamentally and permanently transfers power from the corrupt and toxic British Ruling Elite (who have fatally misused power) to the individual British Citizen. It repairs the damage caused by the Process of Destruction, installs a Sovereign Monetary System, empowers the individual and prevents the imposition of Global Tyranny, the Infrastructure of Slavery and the dictatorship. It could be used as a detailed battle plan for the Freedom Movement.

21. The Counter Revolution provides a new spiritual-political system for empowering the individual for a new era. It breaks virtually every current political taboo, and so those with old thinking caused by brainwashing over many years will despise it. But old thinking has to change. This is a completely new statement, unaligned with Left or Right, or any of the existing political fashions.
22. There must be a new start in society, and so there must be a reassertion of the Universal Spiritual Laws. The **Programme of National Reform** provides that these spiritual principles are built into the legal and political systems to give spiritual meaning and purpose to human existence. The two must now go together.

23. The Counter Revolution is not an attempt to persuade anyone of anything. It is not intended for the vast majority who are brainwashed and asleep. It is addressed to the very few who are already awake and want a practical strategy to stop Global Tyranny operating in Britain. The Counter Revolution provides that strategy.
24. Britain is dying.
25. British civilisation is being deliberately destroyed under the Plan.
26. The **Plan** is a campaign to establish total control over all human beings. The aim is form a world-wide totalitarian dictatorship whereby the dictatorship has complete control over all global energy, all global resources and all global property, and whereby it enslaves every human being in the world in all their activities, emotions and thoughts. The Plan is implemented by the complete extinction of the present civilisation, the annihilation of all individual self-determination and the destruction of all human relationships—and particularly by causing deliberate degeneration of

individuals and society, causing economic collapse, causing collapse of the financial system and causing disruption and reduction of food supplies and energy supplies (the "Process of Destruction"). The Plan is a long-standing process of deliberate and organised evil which is unprecedented in the known history of humanity.

27. The master-mind and driving force behind the Plan is a predatory and parasitic international grouping that has infested humanity for very many years. The Counter Revolution refers to this international grouping as the "Dark Force".

28. Under the Plan, a system of Global Tyranny (the "Great Reset") will be imposed in place of the present civilisation.
29. Global Tyranny is:
- (1) The destruction of all nation states and all democracy.
 - (2) The establishment of international, centralised, digital control systems run by AI algorithms (the "Infrastructure of Slavery") which minutely monitor and control the following, on behalf of the Dark Force:
 - (a) All economies in the world.
 - (b) All global energy, all global resources and all global property.
 - (c) Every human being in the world, with total control of all their thoughts and activities.

30. The process of degenerating individuals and society to bring in Global Tyranny under the Plan is described in Part 2 of The Counter Revolution ("Process of Destruction"). The effects of this process have been catastrophic.

31. The Plan is very near to completion.
32. The British Constitution has irretrievably broken down.
- (1) On instructions from the Dark Force, the British Government, without any health need, used the Fake Virus Crisis to impose State Terrorism upon the British people.

 - (a) **Phase 1:** Deliberately creating psychological conditions to ensure that the people would accept the COVID-19 "vaccine", firstly by deliberate inducement of intense panic over the "virus" and secondly by deliberate dislocation of the population's normal way of life to create deep shock throughout all society.

 - (3) The Fake Virus Crisis with the State Terrorism was the greatest crime in British history.
 - (4) The British Government were openly criminal in lying, deceiving and deliberately generating intense and unfounded fear among their own trusting people, and in imposing the provisions of State Terrorism on fraudulent premises as there was no health need. They deliberately betrayed the British people. This marked a watershed in British history.
 - (5) The British Government followed the directions (and money) of billionaires and their Foundations (operating on behalf of the Dark Force) instead of acting in the best interests of the people.

- (6) During the Fake Virus Crisis and the State Terrorism the existing constitutional arrangements which were supposed to protect the British people against fraud and criminality by the Government completely failed, and a catastrophe took place.
 - (7) The effectiveness of Parliament has increasingly withered until the Dark Force now controls the whole of the British Ruling Elite of politicians, media, judges, senior policemen and administrators. The Dark Force has now established for itself absolute, dictatorial and virtually uncontrollable powers. Parliament is still supposed to be the current source of power but it cannot do its job now.
 - (8) It turned out that there were no provisions in the British Constitution that prevented the Government's open criminality. Those who should have controlled the Executive failed to do so; the House of Lords, the rest of the Cabinet and the MPs failed to prevent the State Terrorism but allowed it to be imposed and to continue. There were no constitutional means for British Citizens to take action to stop the criminality and catastrophe of the Government's State Terrorism.
 - (9) There is currently no power that enables the British people to control the British Ruling Elite; any action always needs an official either to approve it or take action themselves, and since no official is any longer willing or able to hold any of the Executive to account, and such officials misuse their discretionary powers, nothing is done, or can be done.
 - (10) This means that there are no institutional arrangements in the country which can provide any restraining control over the British Ruling Elite.
33. The essence of the relationship between the Government and the People is the Social Contract. The Social Contract provides that the Crown, Government and Parliament **ONLY HAVE POWER WHEN THEY ARE ACTING IN THE INTERESTS OF THE PEOPLE.** (If the Crown, Government and Parliament claim that they can rule and make laws which are NOT in the interests of the People, then that is a tyranny and can be legally resisted.) The Social Contract has always been assumed by the People even though it has never been written down in statute as the British Constitution is unwritten. Judges can adjudicate on laws, but the Social Contract goes beyond the jurisdiction of Judges as it is the foundation upon which laws depend for their legitimacy. When the Crown and the Government cease to act in the interests of the People the Social Contract is broken and the power of the Crown and the Government come to an end.
34. **The Social Contract is broken.** Because the British Government imposed State Terrorism (and the Fake Energy Crisis) on instructions from the Dark Force, (and not in the interests of the British people) the Social Contract is broken. This is the final straw in the corruption of the British Constitution which is now broken irretrievably. This action will never be forgotten or forgiven. Since the Crown and the British Government have manifestly broken the Social Contract, they have ceased to have legitimacy, legality and authority and they have ceased to have any right to exist and exercise power. Accordingly, all their laws to impose the State Terrorism and the

Great Reset are illegal and null and those laws do not need to be obeyed. They are not able to instruct the police to enforce their State Terrorism or impose the Great Reset. Police officers who are instructed to enforce State Terrorism or impose the Great Reset are therefore acting illegally and can be resisted. Police officers must also be aware that they cannot rely on null laws deriving from an illegal Government to justify their actions, and that they are **personally actionable** for all their acts.

35. There is a need for new methods of controlling the Executive that the Executive cannot corrupt.
36. The power of the Crown (in whose name the Government acts), has once again been misused and once again it needs to be reduced substantially. The whole basis of the authority and power of the Government needs to be reassessed. Power must be decentralised. There must be a fundamental transfer of power to the individual.
37. The essential problem is that the Crown, Government and Parliament run by the corrupt British Ruling Elite claim that they have absolute and unrestricted power to do anything they want, to make any laws they want, to impose any restrictions they want, and to limit and prevent judicial control of their actions. **Such a system is effectively a tyranny.**
38. As this system of absolute power has been abused it is no longer acceptable and must be overturned.
39. It must now be immediately acknowledged as follows:
 - (1) That the power of the British people is the supreme power in the country.
 - (2) That the Crown, Government and Parliament are merely delegates of the British people and only have such powers and authority which have been delegated to them by the British people from time to time as the British people in their sole discretion may decide.
 - (3) That each **individual** British Citizen has unrestricted power to judge, review and control the actions of the Crown, Government and Parliament.
40. It is time that the British people broke their chains and took back the power that is rightfully theirs.

41. There must a **fundamental and permanent transfer of real power** from the corrupt and toxic British Ruling Elite to the individual British Citizen.
- (1) The Political Party system will be abolished; all Elected Persons will be independents; they will be contractually bound to their constituents and if they break their contractual duties they can be directly removed by their constituents.

- (2) There will be Direct Democracy where Elected Persons will no longer be "representatives" of their constituents (where they have to do whatever their Political Party tells them), but delegates of their constituents where they are **contractually bound to fulfill legally binding "Delegated Duties"** to their constituents.
- (a) Delegated Duties of an Elected Person can arise in the following ways:
- 1) The Election Manifesto of each Elected Person is legally binding, unless there has been a material change of circumstances.
 - 2) Formal election or other promises given by an Elected Person to their constituents.
 - 3) By holding Local Referendums within the constituency concerned, constituents can require their Elected Persons to vote for and promote the issue decided upon in the Local Referendum.

- (b) Breach of a Delegated Duty by an Elected Person is a Directly Enforceable Offence enforceable directly by any of their constituents, where the Elected Person can be directly removed from office.
- (3) Apart from their State Salaries and State Expenses, all Elected Persons are prohibited from receiving any payment from any person or organisation or acting as paid lobbyist for any cause or organisation, and they are also prohibited from conducting any remunerated occupation or receiving any media appearance money.

- (4) Deliberate lying or deceiving by any Elected Person, or by any person within the British Public Sector, or by any person in a public, official or professional capacity or in the media will be a Directly Enforceable Offence actionable by any British Citizen.
- (5) Constitutional reforms will stop the Crown-Government-Parliament having an absolute power to do whatever they want or pass any law that they want, as is the case now. Limitations will be put in place and if these are exceeded then their laws will be ultra vires and unenforceable.
- (a) The **STATUTE OF DECLARATION** will be enacted. This Statute sets in law that the power and authority of the Crown, Government, Parliament and the judicial system derive entirely from British Citizens (the "People") who are the sole source of all power in Britain. The People are not the servants of the Crown or the ruling elite. The People are the Masters. The Crown, Government and Parliament are merely delegates of the People exercising such powers and authority delegated to them by the People from time to time as the People in their sole discretion may decide. The extent and limitation of such powers and authority is determined by **National Principles** specified under a Statute of Constitutional Delegation and Limitation.
- (b) The **STATUTE OF CONSTITUTIONAL DELEGATION AND LIMITATION** will be enacted. **National Principles** specified under this Statute determine the extent and limitation of the powers and authority delegated at any given time by the People to the Crown, Government and Parliament. Any breach of the **National Principles** is a Directly Enforceable Offence enforceable by any British Citizen.
- This means that for the first time in the country's history, the power base of **Crown-Government-Parliament will no longer have absolute power** to do whatever they want or pass any law they want; the British people now have the right to limit them and hold them to justice.
 - Any legislation passed or action taken in breach of the **National Principles** will be ultra vires, illegal and unenforceable, and any person involved with or voting for such illegal legislation or action (including the reigning Monarch personally) and any person attempting to enforce the same (including any member of the security forces or the police force) will be in breach of a Directly Enforceable Offence and personally subject to penalties in the course of legal proceedings by any British Citizen.

- (6) As the authority of the justice system will now be derived from the British people and not the Crown, the reigning Monarch is personally subject to the law of the land and penalties thereunder in the same way as any other person. The Coronation Oath and the **National Principles** are therefore legally binding on the Monarch, and enforceable by any British Citizen. The Monarch is now personally liable if he or she gives the Royal Assent in breach of the **National Principles**.
- (7) There will be Confirmatory Referendums, Enhanced Confirmatory Referendums, Citizen Initiative Referendums and Local Referendums (in the latter case binding specifically on the local Elected Persons).

- (8) **Citizen Enquiries.** In view of Government and other public activities being deeply corrupted and increasingly hidden from public scrutiny and that there is no uncorrupted institution that can hold the Government and public authorities to account, any individual British Citizen has the right to submit Citizen Enquiries directly to any part of the British Public Sector, to any Elected Person and to certain other specified organisations and processes. The British Citizen can then use the reply to this Citizen Enquiry to support an Application in respect of a Directly Enforceable Offence should they so desire.

- (9) The House of Lords will be abolished and not replaced.

- (10) The Coronation Oath will be amended to incorporate a personal undertaking by the new Monarch to comply with the Statute of Declaration and the **National Principles** specified under the Statute of Constitutional Delegation and Limitation.
- (11) For the first time, every individual British Citizen will be empowered to bring direct legal actions for breach of public duty (with Legal Aid) against, inter alia, the reigning Monarch, the Prime Minister, all Governments including all Local Government, all politicians, all in the British Public Sector (as defined), all in the National Education System and all in the media. This is the system of Directly Enforceable Offences.
 - (a) In Britain the system of law enforcement has always depended on officials of one sort or another bringing whatever action is needed to

enforce the law. Individual British Citizens have no powers to take action themselves. Unfortunately, this system has become corrupted because enforcement of the law now depends excessively on political considerations and not the Rule of Law. The enforcing officials cannot now be trusted to enforce the law with integrity and fairness. Unless changes are made, the Programme of National Reform will not be properly enforced by the corrupt British Ruling Elite and the Dark Force will escape control.

- (b) Accordingly, **individual** British Citizens will be given the power under a Directly Enforceable Offences System to bring actions to enforce the provisions of the Programme of National Reform. This power will be vested in individual British Citizens and not in any officials or groups of any sort, as groups can be taken over and then the individual loses all control.
- (c) The **DIRECTLY ENFORCEABLE OFFENCES ACT** will be enacted. Any individual British Citizen will be able to make an **independent, personal and direct application** to the Direct Enforcement Court to restrain and/or penalise any activity classed as a Directly Enforceable Offence carried out by any person or by any private, public or governmental organisation, and will not require permission from the police, the CPS or any official.

- 42. To bring in the dictatorship of the Dark Force (in Britain and elsewhere) the existing white society and civilisation had to be destroyed; it was not to be improved, but destroyed completely. All peace, harmony and security had to be destroyed, and the whole way of life of white people had to be overturned completely and driven to chaos.
- 43. The aim was the deliberate degeneration, weakening and disempowerment of all white individuals and the destruction of white society and civilisation.

"To destroy a civilisation you have to destroy its values."

- 44. Ordinary, decent white people were to be made ashamed of themselves, their way of life, their culture, their society and their country which, they were told, were morally corrupt and rotten with "hate", "racism", "extremism", "fascism", "discrimination", "unfairness", "injustice", "inequality", "social exclusion", "intolerance", "prejudice", "oppression", "homophobia", "transphobia", "white privilege", "white supremacism", "authoritarianism", "patriarchy" and "xenophobia". All their existing and traditional values had to be eradicated. This attack on white people was devised and organised by the Frankfurt School (who were Jewish) on behalf of the Dark Force. All existing structures, allegiances, group links, identities and loyalties in

white society (cultural, social, political, spiritual, and now even relating to gender) were to be destroyed. All the glue that bound white society together was to be melted, so white people were made rudderless, hopeless, intimidated and disoriented. In particular, the following were to be destroyed: the white family, the key role of masculinity, the ownership of private property, the nation state and all spiritual knowledge. Social decay, confusion, degeneracy, demoralisation, weakening, division, conflict, financial insecurity, resentment and hate were to be caused in countless different ways. Anti-White Hate was to be created and spread. Women were to be divided from men. All sorts of Sexual Dysfunction were to be encouraged. Traditional and familiar words and modes of expression were prohibited, and other words had to be used (the "Corruption of Language"). All white populations were to be subjected to White Replacement by tidal waves of alien cultures in the form of overwhelming and destructive immigration of non-assimilable Africans and Muslims forming very large non-white populations in Britain, by Non-White Privilege and Hate Crimes affecting only white people, and by enforced "multiculturalism", "diversity" (ie the exclusion of white people) and racial quotas. This genocide was planned by Count Richard Coudenhove-Kalergi (who received very significant Jewish support and finance).

45. Those existing and traditional values were to be replaced with a new set of materialistic values designed to destroy white society. These new values are the "Destructive Values" (sometimes called political correctness or woke culture).

46. The Destructive Values Enforcement Machine is an organised system used by the Dark Force to enforce the Destructive Values on society.

47. None of the degeneration and decay caused by the Process of Destruction would have been possible without the active support of the British Ruling Elite and their direct involvement with the Destructive Values Enforcement Machine.
- (1) The **British Ruling Elite** means all those in positions of power, authority and influence in the country, and includes in particular Senior State Officials; Members of all Governments, and politicians of all parties and so-called "nationalist" parties; the entire political, administrative, financial, media, educational, scientific, medical, judicial, legal, professional, entertainment and corporate business ruling elite; those in senior or influential positions in virtually all charities, churches, NGOs, and activist, humanitarian, wildlife, environmental, green, social, religious and spiritual organisations; those in public positions and those in other positions of authority or influence; the super-rich and many celebrities.
 - (2) **The toxic British Ruling Elite.** The Plan could not have been imposed on Britain without the active and deliberate assistance of the British Ruling Elite over many years. A very large proportion of the British Ruling Elite are Dark Force Collaborators. For many people it is utterly life-changing when they first realise that the British Ruling Elite have for many years been actively engaged in trying to destroy their civilisation in its entirety, and have been methodically, deliberately, ruthlessly and secretly implementing the Process of Destruction to advance the Plan; it becomes clear that for decades a secret agenda has ruled all their policies on instructions from those who control them. People then realise that they have been fooled all the time, and there is the greatest anger and the deepest sadness for all that has been lost and destroyed. During the Fake Virus Crisis virtually the entire British Ruling Elite in all positions of authority and influence in Britain were clearly shown to be in on that gigantic crime and were fully supporting and

promoting the State Terrorism. It was clear that this ruling elite were working for the Dark Force and not for the British people; they seemed to be at war with the British people and knowingly betraying them. After all their lies and deceit, never, ever will any of them be believed again. They showed a complete breakdown of all integrity and honesty. By their behaviour they showed that there is no limit to their willingness to destroy the economy and people's lives. Let the British Ruling Elite understand this: we now fully understand what you have done; we are sick of your lies, deceit and pretence that you were helping us—when all the time you were deliberately destroying our civilisation; we are sick of your lies about "world crisis"; we are sick of the filth and degeneracy, unfairness, racism and fear that you have deliberately introduced to corrode our society and our lives. It is quite clear that this highly privileged, weak, self-indulgent and degenerate ruling elite (the toxic product of 40 years brainwashing in higher education) will throw away the whole of civilisation and allow the enslavement of the British people, unless they are all **permanently removed from all power, authority and influence.**

53. There are two critical problems with UK currency and finance.
- (1) Many people think that when a private bank makes a loan, the money comes either from savings that customers have deposited with the bank, or out of funds the bank obtained from the sterling money market, and that in both of these cases the bank will have to pay interest. But this is not the case. The private bank makes the loan with money it created by itself "out of thin air", at virtually no cost to itself at all. Individuals and the British Government borrow from the banks and have to pay them interest! This ridiculous situation is called the Fractional Reserve Monetary System, and is the way that virtually all money is created in the UK. People find it surprising that the Bank of England does not create the money in the UK, and that virtually all the money is created in this way by a monopoly of private banks.

The CBDC is

part of the Infrastructure of Slavery using the Digital ID. The CBDC will enable the introduction of an inescapable Chinese style Social Credit System over every individual, which will mean an end to all personal freedom and self-determination. The CBDC, together with the Social Credit System, gives such total power to the Dark Force over the individual that it can stop the individual spending money in specific or geographic ways, by which they can curtail the individual's activities without any due process. The CBDC is a cashless system; if there is no cash and every person has to have a bank account to conduct any financial transaction at all, that person can be cancelled out of society by someone disabling their account; the person will then be unable to acquire any supplies to sustain life, even food. The Dark Force which controls the bank accounts can withdraw funds from a person's account at any time or simply prevent them from having access to it if the person acts in a way that is detrimental to the Dark Force, or is simply "unnecessary". When the CBDC is fully in place every unit of digital "money" will not be money as it has been known before, but a "Token" (or "credit") recorded on a blockchain and so will be identifiable, trackable and traceable with a record kept in respect of each Token of who has had it and what it has been used for. There will be no privacy whatsoever. The Token system will make it impossible for individuals to acquire privately owned property or accumulate personal wealth as Tokens will only be usable for a limited time, and if they are not used within that time they will expire. Any such Token can be deactivated and cancelled at any time in accordance with the Social Credit System. This will cause complete disempowerment of the individual, so the individual can never be a threat to the dictatorship. This is slavery. Once in place the CBDC could be used to discipline and penalise whole countries if they follow policies deemed to be unacceptable, such as opposing mass immigration.

54. The following corrective action will be taken with regard to UK currency and finance.

There will be procedures to identify all Dark Force Collaborators, and they will be dismissed from any Key Employment Position and barred from holding any future Key Employment Position. Certain classes of persons who are deemed prima facie to be Dark Force Collaborators will have a right of appeal under the Reinstatement Appeals Procedure.

69. The Dark Force control of all information and opinions has allowed it to create a world-wide brainwashing operation of lies and deceit. This process will be broken up and permanently ended so far as Britain is concerned.

(1) Because the Dark Force controls all Governments, Broadcasting, Non-Broadcast Media, Internet and Social Media Monopolies, Scientific, Medical and other professional institutions, Academia, Education, the political viewpoint of all major companies (through Monopoly Capitalism), major public relations organisations, advertising agencies and the Big Three key and immensely influential global news agencies namely The Associated Press (AP), Reuters and Agence France-Presse (AFP) (which control most of the international news coverage in Western media), it controls all information and opinions heard by the vast majority of people. It can ensure that a single and endlessly repeated narrative is consistently given out over these outlets on any subject it wants. Any conflicting information or opinion is censored out as "misinformation" by editorial and administrative decisions of those outlets, or by the activities of the Destructive Values Enforcement Machine. On top of that there is a vast network of domestic and international projects, organisations, conferences and events designed to promote the same messages. The process is a highly effective world-wide brainwashing operation.

(2) By controlling the sole information and opinions heard by the vast majority of people (and the censoring of all alternate views and information) the Dark Force has been able to present unopposed narratives of lies and deceit and thereby create an imaginary Fantasy World made up of ludicrous and patently untrue Fairy Tales (such as gender self-identity). The control of most people during the Fake Virus Crisis also showed the immense power that this process gives the Dark Force.

- (3) These Fairy Tales are then given maximum support by the Destructive Values Enforcement Machine.

70. Action will be taken against malign organisations.

72. Regardless of whether Climate Change is true or not, the use of fossil fuels will be totally eliminated, not to reduce CO₂ emissions, but because they will not be needed at all. A new source of energy will be developed and introduced; this is the "Energy Creation Unit". Accordingly the key demands of Sustainability are made irrelevant: there will be no need for any reduction in the use of energy; no need to limit travelling or to reduce the use of cars; no need to "de-grow the economy"; no need for the "total transformation" of the whole way of life in white countries; and CO₂ can continue to be available as the essential nutrient for the whole of the Earth's biosphere.

- **Energy Creation Units.** The Energy Trust, a nationally owned Statutory Trust financed with Sovereign Money, will be set up to develop over-unity technology that produces free energy, Zero-Point Energy (ZPE); this is the Energy Creation Unit. This technology has already been developed many times by Nicola Tesla and others but it has always been suppressed by the Dark Force. Now it will be developed for the benefit of the whole of humanity. The Energy Creation Unit will be solid state, autonomous and unconnected to any power grid, but will generate phenomenal amounts of clean, limitless, safe and essentially free energy. This will replace the need for all oil, gas, coal, nuclear power, wind, hydroelectric, geo-thermal and solar energy systems currently used on Earth. CO₂ and other finite resources will not be involved in this process and no waste will be created. Energy Creation Units will provide all the energy needs of every person; they can be placed in every car, train, plane, ship, submarine, house, flat, office, workshop, indeed in every place where energy is required. The aim is to make this technology available for every person in Britain to supply all their energy needs for free, from individual and public travel to water and room heating. Eventually it is hoped that such technology will be made available to every person in the world. It will be possible to place Energy Creation Units in the depths of the jungle or in the wastes of the Sahara and will be of the greatest possible benefit to countries and peoples who have so far been unable to rise above intense poverty and insufficiency. This will green the Earth and bring genuine sustainability. Energy Creation Units will transform civilisation and humanity, releasing them from the terrible grip of oil companies and oil producing countries.

73. Financial security.

They will be given an interest free mortgage using Sovereign Money from the National Lending Bank for the whole purchase price without the need for a deposit or in most cases credit clearance (unless the applicant has been guilty of significant criminal behaviour). The mortgage instalments will be equal to their current rent payments. This will allow private farmers to take control of the countryside from corporations, and cherish it without being under pressure from shareholders or the Stock Market.

Community Wealth Building and the Community Food Growing Project are part of this process. Genuine local communities will be enhanced, not the phony "community" of Sustainability/Communitarianism which is a travesty of genuine community and is rejected.

So people will be freed from this curse.

(1) Britain will not implement, comply with or abide by any of the international rules of Sustainability laid down by or on behalf of the United Nations. Instead, Britain will adopt its own proposals to deal with those principles of Sustainability relating to waste, pollution and the environment and to Biodiversity Loss, which will be to higher standards than United Nations recommendations, but without United Nations monitoring, supervision or data collection.

Pandemic Treaty, the Emergency Platform under Our Common Agenda and all other international rules of Sustainability, and be under no legal duty to implement, comply with or abide by them. The International Health Regulations will not be binding on Britain. Britain will not enter into any further such United Nations or international Treaties, Agreements or Conventions.

(4) The individual is the key unit of all social and political constructs. The "community" and the "State" are artificial entities with no reality in themselves, and must therefore serve the individual, not the other way round.

- (5) A strong, healthy and uplifted society is built from the roots upwards with strong, healthy individuals working and cooperating voluntarily together for the benefit of the whole. It cannot be imposed top down by Government edict.
86. As a result of the Process of Destruction vast numbers of people have lost their independence of mind, and they have a great sense of fear, helplessness and moral confusion as a result of all the propaganda, lies, deceit, brainwashing and degeneracy. They have lost all strength of character. They no longer have a set of traditional values as all those have been replaced by the Destructive Values. With the destruction of all spiritual knowledge they have no sense of inner personal validity and no innate direction which provides a strong sense of right and wrong that requires them to make any stand against the programmed degeneration and destruction, and to demand an end to the process.
87. **Spiritual Awareness** is the most effective way of building long-term resistance to all the propaganda, lies, deceit, brainwashing and degeneracy spread by the Dark Force to promote the Plan.

- (1) A colossal change comes over a person when they develop Spiritual Awareness. They understand the Spiritual Destiny of humanity. They know that they are not the confusion, fear and turmoil of the temporary lower self but that they are in reality—and will be for ever—the eternal, indestructible Higher Self; they know that they have a Life Plan and a pre-birth planned purpose to their lives; they know that they survive death and that in their essential nature they are immortal; they have increased spiritual intuition which enables them to see the truth better; they know that they are sovereign and will demand independence and freedom of mind so they can form their own independent opinions. They become active on the path of individual Spiritual Development, and they are no longer afraid of death.
- (2) If enough people could develop Spiritual Awareness the policies of hate, division and degeneration in the Process of Destruction (described in Part 2 of The Counter Revolution) would not be able to work. While humanity has this knowledge, the Dark Force will never imprison humanity for ever, however tight it makes its police state; like corks, humanity will never sink for long but will rise again and the whole Dark Empire will break up and dissolve.
88. The promotion of Spiritual Awareness is integral and fundamental to The Counter Revolution and the **Programme of National Reform**. This involves (1) the acquisition of basic Spiritual Knowledge by the individual, and (2) the encouragement of individual Spiritual Development.
- (1) The basic Spiritual Knowledge that must be possessed by every individual is as follows:
- (a) **The Primary Principle of the Modern Catechism.** The very essence, core and permanent reality of every individual is an eternal, indestructible "Higher Self" which is innate Divinity as it is one with the

One Source, the **ONE CONSCIOUSNESS**. The Higher Self is true joy and absolute unchanging peace, and is the centre of the Spiritual Destiny of humanity and of individual Spiritual Development. The Higher Self is the source of that individual's inalienable validity and uniqueness as a fully sovereign, precious and priceless individual. This Higher Self is currently and temporarily operating through a "lower self" comprised of a physical body with emotions and thoughts and which is conventionally felt and understood as the personal everyday human being. The lower self can be subject to confusion, fear and turmoil.

- (b) The true nature and essence of every individual is their Higher Self and not their temporary lower self.
- (c) **The Spiritual Destiny of Humanity.** Humans are spiritual beings, temporarily living in physical bodies during a series of lives on Earth. The primary purpose of life on Earth for every individual is their Spiritual Development, leading towards their merger with their Higher Self—their innate Divinity, the **ONE CONSCIOUSNESS**.
- (d) Every individual is of precious and priceless value—irrespective of status, wealth, intelligence, race, physical strength, beauty, worldly abilities or talents, social importance, social skills, family origins or connections.
- (e) Every human being survives their death ("transition") and continues to live and evolve spiritually as a fully conscious individual in the Afterlife on the Astral Plane.

- (f) If a person during their lifetime on Earth complies with the Modern Catechism this progressively refines and improves their Spiritual Frequency.

 - **Spiritual Frequency.** As in the case of the physical body, the astral body is constantly passing out particles and taking in new replacement particles which gradually change its nature for good or worse. The high or low quality, purity or "frequency" of these new particles is determined by the thoughts, emotions and actions of the person during their life. This forms the person's "Spiritual Frequency". Spiritual Frequency is significant as firstly it determines the person's Habitual Level on the Astral Plane at the commencement of the Afterlife (and therefore their happiness), and secondly the

refinement and improvement of a person's Spiritual Frequency is integral to that person's individual Spiritual Development.

- (2) The process of individual Spiritual Development will be encouraged and is as follows:
- (a) The essence of Spiritual Development of humanity is the development of individuality with freedom and independence of thought, and then whilst at all times retaining that individuality, the voluntary merging of that individuality within the higher and wider consciousness of their Higher Self.

- (b) There are two parts to us: a Temporary part and a Permanent part.
- 1) The Temporary part (the "lower self", or the personal everyday self, the ego or "me") is all that makes us separate persons such as a physical body, thoughts, emotions, wants, fears, desires of all kinds, possessions, talents, habits, abilities, characteristics, weaknesses, tendencies of all sorts, relationships, the way we look, our facial or bodily characteristics, our self-esteem, our image of ourselves, how we do our hair or anything else that the outside world recognises as "us". This part changes all the time. Sooner or later every aspect of the Temporary part will change. The Temporary part cannot exist without the Permanent part which underpins it all.
- 2) The Permanent part is the "Higher Self" or **PURE AWARENESS** which never changes. This is also sometimes referred to as our True Nature, the Watcher, the Thinker, the SELF. The Higher Self is who we truly are. This is the real "I", It cannot be hurt in any way; it is timeless, changeless, indivisible, indestructible, immovable, without end, without beginning; it is true joy and absolute peace. It is Divine because it is one with the One Source, the **ONE CONSCIOUSNESS**.
- (c) The Higher Self or **PURE AWARENESS** is Permanent and everything else is Temporary. So we are not our bodies, thoughts, emotions or intellect. The Higher Self is not affected by possessions and money or lack of them, our knowledge or lack of it, our importance in society or otherwise, our self-esteem, our image of ourselves, how we dress or how we look, our ups or downs, our successes or failures, our happiness or despair, our winning or losing, our health or sickness, whether people like us or not, whether people approve of us and think well of us or not, whether we are imprisoned or not, whether we can see or are blind, whether we can move or are paralysed, whether we live or die, whether the Earth continues to exist or is destroyed.

- (d) What we really are is the Higher Self or **PURE AWARENESS** temporarily using a body-mind vehicle.
- (e) Spiritual Development is simply a trend over many lifetimes whereby we become less established in the Temporary part and more established in the Permanent part—until eventually the time comes when we are totally established in the Permanent part to the exclusion of all else, whilst always retaining our individuality. The Temporary part is then experienced to be merely a transparent working vehicle (which is all that it is ever supposed to be).
 - 1) We are then permanently lodged in the consciousness of the Higher Self.
 - 2) This is called SELF-Realisation, Liberation, Enlightenment or Awakening.

89. A new political environment will be established based on the Universal Spiritual Laws with the intention of promoting Spiritual Awareness as the most effective way of building resistance to all the propaganda, lies, deceit, brainwashing and degeneracy introduced by the Dark Force.

90. Spiritual Awareness will be promoted under The Counter Revolution in the following way:

- (1) The Universal Spiritual Laws are the central moral root of The Counter Revolution. The Universal Spiritual Laws are the basis of the Modern Catechism, which is comprised of spiritual and ethical principles. Spiritual Awareness is promoted on the principles of the Modern Catechism. The principles of the Modern Catechism are incorporated into the Principles of Good Citizenship.

- (2) The Principles of Good Citizenship will be made mandatory in many public functions and operations.

- (a) All policies, operations, procedures, documentation, training courses and training material used by any part of the British Public Sector will

be redesigned and redrafted in accordance with the Principles of Good Citizenship, and with the removal of any reference to, promotion of or influence from the Destructive Values.

- (3) Each individual will be empowered.
 - (a) **Empowerment of the Individual.** Individual British Citizens will be empowered by the enhancement of their individuality, strength, self-determination, autonomy, self-confidence, self-esteem, self-reliance, knowledge, spiritual understanding, creative thinking, intelligence, rationality and clarity of mental perception. British Citizens will also be empowered by the preservation of the Inherent Rights of the Individual and the Additional Individual Rights of the individual, and by the promotion of their financial, physical, emotional and mental independence and their constitutional sovereignty. Personal financial security and ownership of private property are essential aspects of empowerment. Empowerment of the individual means that there must be more and greater opportunities, choices and options for personal individual expression. Empowerment also means assisting each individual in their own personal Spiritual Development in the most appropriate and suitable way for that individual.

 - (b) Individual entitlement to freedom of expression (of all forms) is inherent to every human being, whose very nature is of unique and precious spiritual value. To achieve their goals the overall aim of the Dark Force is to restrict and deny all individual expression. The Inherent Rights of the Individual are the building blocks upon which individual freedom of expression is preserved and guaranteed—and are supreme over and above the claims of any group interest—and they will be legally enforceable.

- 91. Never before in all known history of this Planet has there ever been a movement on such a scale as that led by the Dark Force, which, for its own selfish material advantage, has been deliberately trying to degrade, degenerate, disempower and impoverish people, to end civilisation and to prevent the Spiritual Destiny of humanity. It is an intensity of evil that has never been seen before and it threatens to

destroy humanity. This is the final battle for the soul of humanity and possibly even for its continued existence on this Planet.

- **The Spiritual Destiny of Humanity.** Humans are spiritual beings, temporarily living in physical bodies during a series of lives on Earth. The primary purpose of life on Earth for every individual is their Spiritual Development, leading towards their merger with their Higher Self—their innate Divinity, the **ONE CONSCIOUSNESS**.
- (1) The Dark Force, their Collaborators and all their followers represent the old humanity, based on the purely material values of: domination; inducement of fear; selfish manipulation and exploitation of others with corruption, deceit, intimidation, bribery and blackmail; their overriding selfish concern for the interests and advancement of their own lower self; lack of genuine concern or kindness for the interests of others. The characteristics of this old humanity and this poisonous global elite must now leave the Earth and allow a new humanity to emerge, sincerely motivated by the principles of the Universal Spiritual Laws and with deep respect for all other individuals of whatever status.
 - (2) The process of Spiritual Development in an individual is the progressive revealing of **CONSCIOUSNESS** within, by the removal of restrictions caused by the uncontrolled activity of the individual's thoughts and emotions. That is why the activities of the Dark Force are so evil, because they tie people down with low, polluted and entrapping thoughts and emotions by deliberately and intentionally creating negativity.
 - **Negativity.** Negativity is the existence of low energy patterns and comes from: fear, hate, turmoil, distress, anger, resentment, worry, grievance, conflict, a sense of crisis, division, disharmony, confusion, unhappiness, limitation, frustration, depression, hopelessness, addiction, depravity and degeneracy.

92. **The Plan must not be allowed to succeed, for if it does succeed, the spiritual destiny of humanity will be impeded**
93. **Direct Action.** For typical British people, obedience to the law is one of the key pillars of their civilisation. However that belief developed when they thought they were

entitled to the Inherent Rights, particularly the Inherent Rights to Self Determination and Freedom of Speech, and that it was a "free country". However, the Inherent Rights are now denied and there are ever-increasing powers of repression. The corrupt Dark Force-controlled British Government and corrupt Dark Force-controlled Broadcasting (and other media) are acting in lockstep to prevent the expression of any information or opinion that does not follow the official Dark Force narrative. Everything the British Ruling Elite does is calculated to promote the Plan, and the Plan means slavery for the British people. The laws which the British Ruling Elite are using to force the British people into Dark Force tyranny and slavery are not divine laws, but man-made laws. As the Social Contract has been betrayed causing the British Constitution to be irretrievably broken down, and these man-made laws are designed to enslave them, the British people are not required to obey them. The British Ruling Elite will never, ever stop doing what they are doing, but no change is possible because they have twisted and manipulated the system by setting in place laws and rules which protect them and prevent them ever being removed. Changes are not possible within the law because the Dark Force controls the British Ruling Elite and all political parties. All the political, administrative, media, medical, educational, financial and social structures in the country are so corrupted in their very essence that they cannot be reformed within the current system. Democracy is corrupted and pointless, and so cannot function. All conventional opposition to the Plan still tries to operate by way of political parties within the existing constitutional system of this country—but this is now pointless as the existing constitutional system has been irrevocably corrupted, and all opportunities for real opposition have been closed down. The British Ruling Elite (Dark Force Collaborators) prevent all forms of opposition and gradual reform within the current system is no longer possible; so the British people are left with nothing except direct action, between them and slavery. **Direct action outside the law is therefore necessary to make the needed reforms.** The process of reform must be initiated from outside the current system. The British Ruling Elite have created for themselves a total monopoly over power, and since they are determined to impose Global Tyranny and the Infrastructure of Slavery on the British people on instructions from their international controllers, the British people have **NO ALTERNATIVE** than direct action, otherwise they will be slaves.

94. We will not be slaves, we would rather die. The future of humanity is at stake. We do not agree to submit to slavery to comply with a corrupt Constitution or a corrupt ruling elite or a corrupt legal system. If the British Government (or ruling elite) try to impose Global Tyranny on us, then they will be resisted with every power at our disposal to prevent that happening.
95. **WE WILL NOT GO INTO SLAVERY PEACEABLY.**
96. All the reforms mandated under the **Programme of National Reform** must be implemented immediately.

97. The Counter Revolution notifies the Crown, the Government and Parliament as follows:

TO THE CROWN, THE GOVERNMENT AND PARLIAMENT:

- (1) *Since you have broken the Social Contract with your COVID-19 and State Terrorism laws and activities, the British Constitution has broken down irretrievably and you are now illegal:*
- (a) *We will not comply with your illegal laws.*
 - (b) *We will not comply with your illegal police officers.*
 - (c) *We will not comply with your illegal courts and judges.*
 - (d) *We will not comply with your illegal penalties and fines.*
 - (e) *We will not comply with anything you do or say, for you are illegal.*
- (2) *We demand that you comply with the "Programme of National Reform":*
- (a) *You must enact the Statute of Declaration.*

- The **STATUTE OF REFORM** will set up a dedicated body entitled the Transitional Council of State with all necessary powers to ensure that all reforms mandated under the **Programme of National Reform** are put in place. The Transitional Council of State is given the duty of creating all the necessary Regulations and Statutory Instruments to enact these reforms. The Regulations and Statutory Instruments concerned must be appropriate to enact the wording and intent of the Programme of National Reform, not more nor less. The Transitional Council of State is not part of or answerable to the Government. Although it is technically a part of the British Public Sector, it is only answerable to British Citizens as a whole. Once all these reforms have been enacted and established the Transitional Council of State will stand down; it will have no further powers or activity and it will cease to exist.

(3) *As soon as the Programme of National Reform has been complied with, there must be an immediate General Election to elect a new and reformed House of Commons of independent MPs with no political parties, on Direct Democracy owing legal duties to their constituents. The Reformed Electoral Provisions will apply to every Parliamentary candidate.*
